

### ANNEXURE - I

### Contractor scope of work:

2. The Contractor should take care of their staff safety. Necessary PPE's should be arranged by the Contractor.

3. At least two days before the shutdown of the unit, the Contractor has to mobilize their

- 4. The auxiliary cooling water both inlet and outlet 3 inch pipe lines from header pipe near pump house to IAC station are to be isolated by providing two numbers of 3 inch gate valves with flange joint in both inlet and outlet pipe header line near tape off of pump
- 5. The entire length approximately about 120 meter of 3 inch pipe at 6 / 9 meter height level located in pipe rack are to be removed by cutting using suitable machine or gas. Required machine and cutting wheels / gas cutting set are to be arranged by contractor.

6. All removed pipe should be de-chocked by means of manual/mechanical.

- 7. Lengthy pipe shall be cut in to 3 to 4 meter long pieces to facilitate easy cleaning and scale removal inside the all pipes.
- 8. After cleaning/de-chocking of the pipes, same old pipes are to be re installed in the same position as per the existing pipe layout by cutting and welding.
- 9. Necessary scaffolding materials and sufficient manpower are to be arranged by the contractor so as to complete the entire work on stipulated period.
- 10. Welding machine, welding rods (IS make only) welding cables, power cables, , cutting set and Gas cylinders to be arranged by the contractor.
- 11. Wherever necessary, welding and gas cutting works at position is to be carried out without disturbing the existing pipe lines.
- 12. Leak test to be carried out if any leakage is noticed that is to be attended by the concern.
- 13. After completion of work all the scrap materials should be dumped to scrap yard as per the Engineer in-charge.

### PPCL Scope of work

- 1. Necessary pipes/fittings/plates are to be supplied by PPCL.
- 2. Air, Water and Power will be provided by PPCL.
