- 10. **EARNEST MONEY DEPOSIT**: An Earnest Money Deposit of `Rs.2,000/- (Rupees Two Thousand Only) should be paid by demand draft drawn in favour of the Executive Engineer (Mech), Puducherry Power Corporation Ltd T.R. Pattinam, Karaikal on any Nationalized/Schedule bank payable at Karaikal. The same should be enclosed along with tender /quotation failing which tender will be summarily rejected. The earnest money deposit will bear no interest and will be released after successful completion of the works and acceptance. The EMD will be returned to unsuccessful bidders.
- 11. PSU & Parties registered with NSIC or SSI or MSME are exempted for submitting EMD/SD. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
- 12. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money" and "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. The officer opening the tenders shall first open the envelope containing the earnest money. If the earnest money is found to be in order, only then the Officer shall proceed further with opening the tender. In case the earnest money is not deposited or is not in order, the tender will be rejected.
- 13. Liquidity Damage Clause: If the contractor fails to complete the work as scheduled after placing the work order, then the Contractor shall pay LD @ 0.5% for each day delay in work and the total LD % will be subject to the maximum of 10% of the total value.

ANNEXURE-1

SCOPE OF WORK FOR COOLING TOWER FAN 1 & 2 FRP DUCT SEGMENT REPLACEMENT WORK

CONTRACTOR SCOPE:

- 1. The Contractor should be responsible for the safety of their personnel & their equipment. Necessary PPE and other safety norms should be followed.
- 2. The Cooling Tower Fan 1 & 2 old Fan cylinders FRP segments are to be removed from the site one by one as indentified by the Engineer In-charge without damaging the existing hoods.
 - 3. New FRP ducts are to be shifted from PPCL stores to site cooling tower top floor.
 - 4. The new FRP ducts are to be erected in CTF 1 & 2 with existing old ducts by means of fasteners after drilling holes in New FRP segments site folding as well as the FRP foot on concrete base as per the existing system and dimension.
 - 5. Erection of all FRP duct segments in position and lifting of materials by using suitable lifting equipments.
 - 6. Steel structure supports which are removed or disturbed during this work are to be again refixed on FRP ducts with existing supports.
 - 7. Painting on all FRP duct's steel structural supports (two or more coats) after manual cleaning and preparation of surface etc as directed by the Engineer in charge. All consumables for painting (brush, emery, waste, etc.,) will be contractor's scope.
 - 8. While execution of work. If any damage occurs to the existing FRP system it has to be repaired by FRP patching by contractor and the cost will be deducted from the contractor for unrepairable segments.
 - 9. Mobilization of manpower and tools and tackles by the contractor should start at least one day before shut down of the unit for replacing the existing line.
 - 10. Necessary scaffolding, scaffolding material and sufficient labour are to be arranged by the contractor, so as to complete the entire work within the stipulated period.
 - 11. Welding machines, drilling machine, welding cables, Cutting set, Gas cylinders and other consumables are to be arranged by the contractor.
 - 12. The entire work should be completed within 07 days.
 - 13. After completion of work all the scrap materials should be dumped to scrap yard, as per the instruction of Engineer in-charge.
 - 14. One site supervisor is to be deputed for early completion of work.
 - 15. The party should visit the site before quoting the rate.

PPCL SCOPE:

- 1. Welding electrodes. Paint and necessary fasteners sill be supplied by PPCL.
- 2. Electricity and water will be provided by PPCL.
