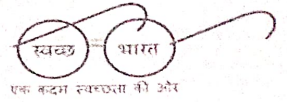

Otherwise 80% payment will be made after completion of work satisfactorily and approval of Engineer-in-charge and the balance 20% payment will be made after submission of necessary EPF & ESI, etc. documents.
3. The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment.
4. Necessary Gate pass should be obtained well before the commencement of work.
5. All the Safety Rules as per the Factory Act 1948, Puducherry Factory Rule and PPCL Safety instructions to be strictly followed inside the plant area.

In addition to the above as a mandatory, the proposed parties/manpower supply contractors have to obtain the FORM-III -Registration certificate under Pondicherry shops and Establishment Rules 1964 as a Employer of the Establishment to be permitted to employ persons under their firm and also obtain Labour License under the contract labour (Regulation & Abolition act. 1970 with the labour Department, Government of Puducherry, Karaikal.

ANNEXURE-I

Scope of work for Pressure Vessel Testing:

1. The certification by a Chartered Engineer for the pressure vessels in the PPCL Plant has to be arranged by the contractor.
2. The party should visit the site before quoting the rate.
3. The Chartered Engineer shall have been authorized by the Inspectorates of Factories, Pondicherry Government.
4. The contractor has to arrange for the transport and facilities to the PPCL Plant for the Chartered Engineer for the field inspections decided by the Chartered Engineer.
5. Safety Isolations, Electrical power supply, overhead trolley crane shall be provided by PPCL.
6. The works have to be started on each day after safety gate pass permission, safety isolation for equipment, work permit and all to be availed from the PPCL Engineer.
7. The party should carry out physical inspection of all pressure vessels
8. The party should carry out systematic non destructive test like ultrasonic test for metal thickness or other defects of the vessel.
9. The party should bring all necessary tools and tackles for testing of various pressure vessels.
10. The party should bring necessary manpower to carry out the above work.
11. The certification of pressure vessel testing to be made in the form No.8 as stipulated in Puducherry factory rules-60.
