Scope of work

- 1. Conduct safety assessment of the works prior to commencing.
- 2. Ensure equipment and tools in use are certified by NABL, Certificate should be enclosed.
- 3. The test equipments such as clamps Kit, etc including consumables are to be arranged by the contractor. All the Tools /tackles will be arranged by the Contractor.
- 4. Perform necessary tests as per the safety valves settings specified in the manual.
- 5. Only accredited service providers will be allowed to perform the trevitest of safety valves.
- 6. Trevi test to be conducted in on load (Boiler in operation) in the presence of Engineer incharge.
- 7. While testing, the condition of the boiler system to be in stable.
- 8. The set Pressure to be achieved within the tolerance as mentioned in manual.
- 9. On completion, remove all kits & equipments and replace the safety valve cover cap and secure the valves by clamping/sealing.
- 10. A calibration certificate with the valves unique number, contractors' name, set pressure value, date of test is submitted as per the statutory format.
- 11. The rate should be quoted in lump sum basis.

12. Fulfillment of all statutory obligations like ESI, PF, and other pertaining to you/employees for execution of the job.
