3. The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment.
4. **EARNEST MONEY DEPOSIT:** An Earnest Money Deposit of Rs.8,400/- (Rupees Eight Thousand and Four Hundred only) should be paid by demand draft drawn in favour of the Executive Engineer (Mech.), Puducherry Power Corporation Ltd T.R. Pattinam, Karaikal on any Nationalized/Schedule bank payable at Karaikal. The same should be enclosed along with tender /quotation failing which tender will be summarily rejected. The earnest money deposit will bear no interest and will be released after successful completion of the works and acceptance. The EMD will be returned to unsuccessful bidders.
5. PSU & Parties registered with NSIC or SSI or MSME are exempted for submitting EMD/SD. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
6. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money and PQR" & "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. The officer opening the tenders shall first open the envelope containing the earnest money and PQR. If the earnest money and PQR is found to be in order, only then the Officer shall proceed further with opening the tender. In case the earnest money is not deposited or is not in order, the tender will be rejected.
7. The bidder should provide pre-existing document for PQR copies as and when asked within one week time.

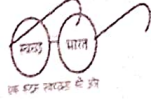
In addition to the above as a mandatory, the proposed parties/manpower supply contractors have to obtain the FORM-III -Registration certificate under Pondicherry shops and Establishment Rules 1964 as a Employer of the Establishment to be permitted to employ persons under their firm and also obtain Labour License under the contract labour (Regulation & Abolition act. 1970 with the labour Department, Government of Puducherry, Karaikal.

10. Necessary Gate pass should be obtained well before the commencement of work.
11. All the Safety Rules as per the Factory Act 1948, Puducherry Factory Rule and PPCL Safety instructions to be strictly followed inside the plant area.
12. In case of any faulty workmanship in the scope of work, the tenderer must rectify the same. Otherwise the estimated amount will be deducted in your work bill.
13. Our GSTIN No.: 34AAACP6507E1ZS registered with Commercial Taxes Department, Puducherry.
14. **Liquidity Damage Clause:** If the contractor fails to complete the work as scheduled after placing the work order, then the Contractor shall pay LD @ 0.5% for each week delay in work and the total LD % will be subject to the maximum of 5% of the total value.

ANNEXURE

Contractor scope of work:

1. Dismantling of connected oil pipeline/vent lines to bearing housing.
2. Dismantle the Governing hydraulic actuators, pilot valve tripping gear system etc. connected to front journal housing
3. Take necessary clearance readings of bearing housing internals
4. Remove the old Trip gear assembly from pedestal housing.
5. Open Top cover of bearing pedestal and inspect the trip lever bolt attached to the shaft. Install new trip gear assembly with existing trip lever.
6. Set the trip lever clearance as per the recommendation of OEM M/s. BHEL.
7. Reassemble Governing hydraulic actuators, pilot valve tripping gear system etc. connected to front journal housing and fixing back of all oil lines.
8. No load trial and load trial has to be carried out. If any correction required after trial operation it also to carried out.

CONTRACTOR SCOPE:-

1. Mobilization of manpower by the contractor should start at least two days before shut down of the unit.
2. All tools, rigging tools and tackles inclusive of drill and reamer set to complete the job are contractor's scope
3. If any machining work required, it also to be arranged by the contractors.
4. Work should be carried out within 5 days from the date of plant shutdown.
5. The part should visit the site before quoting the rate.
6. The party has having experience of such type of work (Steam turbine erection/service/repair/assembly work) and the party should submit the necessary document along with the offer.

Consumables will be provided by PPCL (rubber gasket, water gasket, paint brush, wire brush, Petrol for cleaning etc.)
