- Dismantling of Existing DC AB Switch. i.
- Erection of new DC AB Switch in the existing DP Structure including fixing of all ii. operating pipes, complete switch assembly will be supplied by PPCL.
- To check Open /Close proper seating operations of the existing Double Contact AB iii. Switches and aligning properly so as to minimize vibration for smooth operations are in contractor's scope.
- However any repair works involving machining or fabrication with required welding iv. machine & cutting sets are in agency scope.
- Cleaning of all the parts, removal of damaged parts & replacing with entire materials V. are in contractor's scope.
- All required special tools and tackles, scaffolding arrangement for completion of the vi. above works have to be arranged by the contractor.
- Consumables like anti corrosive metal primer, enamel paint, HT cable end vii. termination sleeves, lugs, bolt & nuts, Vaseline, oil & etc have to be arranged by the contractor.
- Removal & replacing of all damaged jumpers, connectors, cable end HT lugs & cable viii. end outdoor heat shrinkable sleeves, HT insulations where ever necessary and replacing of all post top supporting insulators (03 no's in each feeder) are in contractors scope.
  - The contractor should submit the labor charges for commission, maintenance works ix. with required materials servicing cost with materials for each feeder so that easier for the party to claim the bill individually after completion of servicing work one by one. (To be quoted in the tabular column).
  - If required lightning arrestors to be replaced by the contractor and also to check X. earthing flat connections and re-strengthening of existing HT line guarding in the feeders are in contractor's scope.
- The entire structure has to be painted with one coat of zinc chromate metal primer xi. and two coats of aluminum paint by the contractor.
- The contractor should mobilize sufficient manpower with materials to complete the xii. above works for a single feeder within a day i.e. 08 Hrs.
- Necessary shutdown/ LC will be issued by PPCL after getting LC approval from xiii. Electricity Department so that the contractor should plan the work according to the LC.
- Before submitting the offer the contractor should visit the site for accessing the work xiv. and materials required for completion of the above work.
- In case of any faulty workmanship in the scope of work, malfunction the Contractor XV. must rectify the same at their own cost.
