- 4. ANNEXURE-II

Scope of work

AUXILIARY/COOLING WATER PIPE LINES - CLEANING AND PAINTING- SUPPLY AND APPLY (APPROX AREA: 500 SQ .MTR)

1. Manual cleaning and preparation of surface by machine/manual or sand blasting etc, on steel work as directed by the Engineer in charge.

2. After cleaning work on the pipe surface, Corroded portion to be indentified and patch welded wherever required. Required MS plate material to be supplied by PPCL.

3. The quantity surface area mentioned in the schedule is approximate only. Measurement will be taken by the representative of the Engineer-in-charge in the presence of the contractor and payment will be made on the actual quantity of work executed, measured jointly.

4. The total amount is inclusive of manpower (welder, painter skilled and unskilled), paints, consumables (Painting brushes, wire brushes and emery sheets etc.,), taxes and other charges.

5. The rate includes necessary scaffolding charges and other inputs, which will involve during the progress of work.

6. Primer Coat: After surface preparation, high build one coat epoxy mastic surface tolerant primer paint (Approved Make- Asian, Nippon, Nerolac, Berger, Shalimer). The thickness of coat shall be 100 microns.

7. Finishing Coat: Apply by airless spray two coats of epoxy/Polyurethane paint (Approved Make-Asian, Nippon, Nerolac, Berger, Shalimer) giving sufficient time gap between two coats to enable the first coat to become dry. The thickness of each coat shall be 40 microns. Color of paint Aquamarine green & amp; dark green color or as per engineer instruction.

8. No coat shall be applied until the preceding coat dries off completely. Same Make of paint material shall be used for both primer and finish coat.

9. Party shall make its own arrangements for Tools and Tackles, compressor hiring, hopper, consumables, paint, Ladder and Other Rigging Material like scaffoldings required for the job.10. Necessary identification/ direction mark shall be marked on pipe surface wherever required approximate at 8 places.

11. Before submitting the offer, party / their representative should visit the site of PPCL, Karaikal to have correct assessment of the job.

12. After completion of all works, working area / floor to be cleaned. Necessary safety measures should be strictly followed inside the premises. (like – Gloves, Helmet etc., under contractor scope) 13. Safety during Work: Contractor must provide safety equipment (PPE) to his workers during work at site. Contractor must depute a qualified supervisor at all times during the work. He shall be responsible for ensuring safety at site.
