The bidder should have enclosed supporting documents within last five years for at least for an amount of (i) Single order for a value of Rs. 2,80,000/- (Rupees Two lakks Eighty Thousand or above) or

- (ii) Two orders each for a value of Rs. 2,10,000/-(Rupees Two lakhs Ten Thousand or above) or

- 1. The rate quoted should be inclusive of manpower, tools and tackles, etc. required for the works, all taxes, EPF & ESI charges and other charges as admissible. GST Compliance will be made as per the latest GOI orders.
- 2. 100% Payment will be made within 30 days from the date of receipt of your invoice after completion of work satisfactorily and approval of Engineer-in-charge and after submission of EPF/ESI, etc. documents. Otherwise 80% payment will be made after completion of work satisfactorily and approval of Engineer-in-charge and the balance 20% payment will be made after submission of necessary EPF & ESI, etc. documents.
- 3. The bill in triplicate along with advance stamped receipt should be sent for effecting payment.
- 4. Rate should be quoted per work in the tabular column attached. The L1 position shall be arrived on total amount quoted basis for completing the entire scope of work furnished in the annexure.
- 5. The Contractor / Agency awarded with work order shall make payments for ESI & EPF in separate code number other than PPCL code. No permission shall be given for PPCL code.

- 10. Our GSTIN No.: 34AAACP6507E1ZS registered with Commercial Taxes Department, Puducherry.
- 11. EARNEST MONEY DEPOSIT: An Earnest Money Deposit of TRs.7,800/- (Rupees Seven Thousand Eight Hundred Only) should be paid by demand draft drawn in favour of the Executive Engineer (Mech), Puducherry Power Corporation Ltd T.R. Pattinam, Karaikal on any Nationalized/Schedule bank payable at Karaikal. The same should be enclosed along with tender /quotation. The earnest money deposit will bear no interest and will be released after successful completion of the works and acceptance. The EMD will be returned to unsuccessful bidders.
- 12. PSU & Parties registered with NSIC or SSI or MSME are exempted for submitting EMD/SD. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
- 13. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money" and "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. The officer opening the tenders shall first open the envelope containing the earnest money. If the earnest money is found to be in order, only then the Officer shall proceed further with opening the tender. In case the earnest money is not deposited or is not in order, the tender will be rejected.
- 14. Liquidity Damage Clause: If the contractor fails to complete the work as scheduled after placing the work order, then the Contractor shall pay LD @ 0.5% for each day delay in week and the total LD % will be subject to the maximum of 5% of the total value.

CONTRACTOR SCOPE OF WORK

- 1. The party should visit the site before quoting the rate.
- 2. The Contractor should take care of their staff safetý. Necessary PPE's should be arranged by the Contractor for their staff.
- 3. The Motor and Gear box coupling, fan blades hub and all spares structures which are all connected to CTF are to be dismantled as per instruction.
- 4. The old Gear box which was laid inside the CTF is to be taken-out after dismantling fan blades, hub, drive shaft, motor etc.
- 5. The existing bed frame to be repaired by cutting and welding, grinding and to be painted. Spare gear box to be installed in line with motor centre.
- 6. New fan blades with Hub and drive shaft to be installed as per the instruction of engineer Incharge.
- 7. Lifting of materials like gear box, bed frame and Erection of gear box in position by using suitable hydra crane long telescopic boom crane are Contractor's scope.
- 8. Sufficient skilled unskilled and Laser alignment technical expert manpower are to be arranged by the contractor to complete the entire work on stipulated period. Arrangement of necessary scaffolding materials are contractor's scope.
- 9. If FRP hood which are removed if any for during installation, to be reinstalled without damage.
- 10. Welding machines, Welding rods, welding cables, Power cables, Cutting set & Gas cylinders are to be arranged by the contractor.
- 11. Wherever necessary, welding and gas cutting works at position is to be carried out without disturbing the existing system.
- 12. After completion of installation work, complete alignment to be carried out on both gearbox to drive shaft and drive shaft to motor are to be carried out using laser alignment technique in presence of Engineer-in charge.

- 15. Party shall make its own arrangements for Tools and Tackles, consumables welding rod paint and Other Rigging Material like scaffoldings required for the job.
