Design, manufacture, testing & supply of mist eliminator filter element (Coalescing Filter) as per the specification with Tank Gasket quantity 02 nos for Oil Mist Eliminator for 22.5 MW BHEL make Frame-5 Gas Turbine Units at Puducherry Power Corporation Karaikal including transportation, transit insurance, loading & unloading at site and taxes as applicable and providing 18 (eighteen) months warranty for satisfactory performance of filters.
- 3. The successful bidder shall provide warranty for 18 months from the date of installation with free replacement against manufacturing defects, normal wear and tear during warranty period.
- 4. The work/supply covers design, manufacture, testing & supply of Coalescing Filter Element with Tank Gasket for Filter Element suitable for Oil Mist Eliminator OE-158B-500 Equivalent to Dollinger part number of element : 95-137 for 22.5 MW BHEL make Frame-V Gas turbine unit at puducherry power corporation, karaikal.
- 5. The successful bidder shall provide interchangeability certificate fo this mist eliminator filter along with supply.
