#### **Scope of Work:**

- 1. Contractor has to collect the lubricating oil samples from Gas Turbine and Steam Turbine at PPCL, T.R.Pattinam, Karaikal. Transport charges and NAS 0 collection bottles are to be borne by the vendor.
- 2. Necessary test has to be carried out on Servo Prime 32T oil which is in service from January-2019 in Gas Turbine (Make: Indian Oil Corporation Ltd.) and Turbinol XT 46 oil which is in service from May-2014 in Steam Turbine (Make: Hindustan Petroleum Corporation Ltd.). 3. Test should be carried out through authorized Government recognized laboratory (NABL Accredited) and submit the original test reports for the following parameters.

1.	Viscosity At 40 Deg.C as per ASTM D445
2.	Viscosity At 100 Deg.C as per ASTM D445
3.	Viscosity Index as per ASTM D2270
4.	Total Acid Number as per ASTM 664
5.	Flash and Fire Point as per ASTM D92
6.	Rust Prevention as per ASTM D665
7.	Moisture content as per ASTM D1744
8.	Particle count - ISO 4406 / NAS as per 1638
