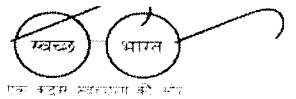
**Terms & Conditions:**

1. The rate quoted should be firm and inclusive of all taxes and other charges plus Service charges for installation.
2. The materials should be directly supplied to the PPCL site, T.R.Pattinam, Karaikal - 609 606, on door delivery basis.
3. Supply portion: payment will be made within 30 days from the date of receipt of your invoice after receipt of materials at site in good condition. **The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment for the supply portion.**
4. Work portion: Service charges for Installation Payment will be made within 30 days from the date of receipt of your invoice after completion of work satisfactorily and approval of Engineer-in-charge and after submission of EPF/ESI, etc. documents. Otherwise 80% of payment will be made after completion of work satisfactorily and approval of Engineer-in-charge and the balance 20% payment will be made after submission of necessary EPF & ESI, etc. documents.
5. **The rate to be quoted for material portion (supply) and Service charges for installation separately and L1 shall be arrived on total amount basis.**
6. (i) Supply: The delivery period and mode of despatch should be clearly specified. Early delivery is requested. The maximum delivery period is 90 days.  
(ii) Work: The service is to be completed within three days. The information for commencing work at site shall be communicated appropriately.

7. The party at their own cost should arrange transit insurance, if necessary.
8. **EARNEST MONEY DEPOSIT:** An Earnest Money of **Rs.2,200/- (Rupees Two Thousand Two Hundred Only)** should be paid by demand draft drawn in favor of the Executive Engineer (Mech), Puducherry Power Corporation Ltd T.R. 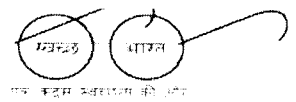

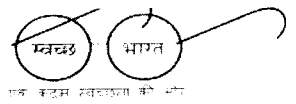

**Scope of supply**

1. All steel parts from inlet to outlet flange with back-up bar and their fixing fasteners.
2. Acouseal KEI FLUAFLEX / single or multi layer of EPDM or otherwise selection of Fabric combination to suit the Gas turbine Inlet air duct mentioning the MOC according to data sheet.
3. Test certificate to be enclosed for fabric material along with supply.
4. Gaskets and Duct fasteners should be IS standard.
5. Hold up bars with suitable safe packing for Transportation.
6. General arrangement of drawing with MOC should be submitted along with offer.
7. Material should be guaranteed for 12 months from the date of commissioning.
8. Site engineer to be deputed while erecting at various joints.
9. The contractor may visit the site before starting work for further technical details required.

**Steel Part Type:**

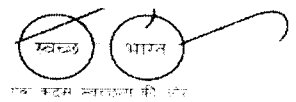
1. The Steel Parts shall be selected based on the duct drawing or necessary dimensions and specification as per the existing system to be selected at PPCL site.
2. The expansion joints shall be Standard Angle flange type to suit the specified operating conditions.
3. All steel frames shall be made of IS2062 material, and the duct thickness has been considered 5 mm and other dimensions shall be as per the drawing 3A5535499. The Duct fasteners shall be of standard GI grade only.
