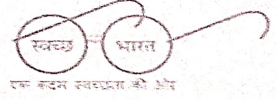

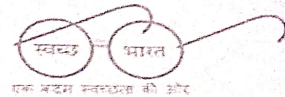

TERMS AND CONDITIONS:

1. The rate quoted should be inclusive of repair work, material, manpower, tools and tackles, etc. **GST, Transportation charges (To & Fro) and other charges** as admissible.
2. 100% Payment will be made within 30 days from the date of receipt of your invoice after completion of work satisfactorily and approval of Engineer-in-charge
3. The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment.
4. **Rate should be quoted per work in the tabular column attached. The L1 position shall be arrived on total amount quoted basis for completing the entire scope of work furnished in the annexure for all valves. All items have to be quoted.**
5. Necessary Gate pass shall be arranged by PPCL for taking material to your Workshop.
6. In case of any faulty workmanship in the scope of work, the tenderer must rectify the same. Otherwise the estimated amount will be deducted in your work bill.

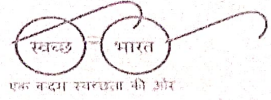
8. **EARNEST MONEY DEPOSIT:** An Earnest Money Deposit of Rs. 4,300/- (Rupees Four Thousand Three Hundred Only) should be paid by demand draft drawn in favour of The Executive Engineer (Mech), Plant Puducherry Power Corporation Ltd T.R. Pattinam, Karaikal on any Nationalized / Schedule bank payable at Karaikal. The same should be enclosed along with tender / quotation failing which tender will be summarily rejected. The earnest money deposit will bear no interest and will be released after successful completion of the works and acceptance. The EMD will be returned to unsuccessful bidders.
9. **Guarantee Certificate:** Guarantee certificate should be produced along with bill guaranteeing the valve serviced for the period of 6 months (Six months) from the date of receipt at site for satisfactory operation and good workmanship.
10. **Adequate time has to be given for inspection before delivery.**
11. PSU & Parties registered with NSIC or SSI or MSME are exempted for submitting EMD/SD. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
12. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money" and "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. The officer opening the tenders shall first open the envelope containing the earnest money. If the earnest money is found to be in order, only then the Officer shall proceed further with opening the tender. In case the earnest money is not deposited or is not in order, the tender will be rejected.
13. **Liquidity Damage Clause:** If the contractor fails to complete the work as scheduled after placing the work order, then the Contractor shall pay LD @ 0.5% for each week delay in work and the total LD % will be subject to the maximum of 5% of the total value.
14. Sealed quotation should be super scribed as "**QUOTATION / ENQUIRY NO. AC-084 "Non IBR old valves repair/reconditioning work" - due on 27.10.2025**".
15. Applicable other charges, if any should be clearly mentioned as whether inclusive or exclusive. If not mentioned, it will be presumed that the rate quoted is inclusive of all taxes other charges.
16. The undersigned reserves all rights to accept/reject any or all the quotations without assigning any reasons thereof.
17. The work should be completed within 30 days from the dispatch of Non -IBR valves from PPCL site. The mobilization time of two week shall be given.

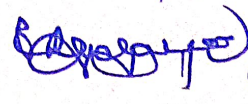

ANNEXURE-1

SCOPE OF WORK:

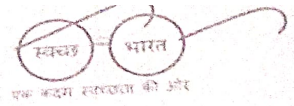
1. The party should visit the site to access the condition of the valves to be serviced, before quoting the rate. Work to be carried out in their work shop.
2. Transport charges (To & Fro) will be borne by the contractor from PPCL to their workshop and vice versa.
3. Dismantling of all valves and Cleaning of internal and external parts completely by Sand blasting.
4. Inspection of the seating area, valve body, bonnet etc.
5. Repair the worn out/damaged spindle/Nut by welding with dissimilar electrode and to grind/machine to obtain correct fit (reduce the slackness)
6. Repair the plug and seat by welding, grinding and lapping to get blue contact between seat and plug. Appropriate welding electrode to used for plug and seat repair work
7. Lapping the Seat surface and blue matching for zero % passing.
8. Repairing by welding of damaged body bonnet and other parts by proper welding procedure.
9. Repair the back seating area of valve by welding, machining, grinding and lapping to get blue contact.
10. Assembling of valves with new gasket, Grafoil Gland packing and replacement of worn-out/missed fasteners.
11. Checking the valve spindle for smooth operation and for full opening / closing.
12. Checking the Gland packing & Bonnet joint for zero leakage. Checking the valve operation in full assembled condition.
13. Hydro testing of the valves to the Test pressure as per API 598. Necessary pressure test certificates to be produced along with valves.
14. Painting of Valves by proper procedure.
15. Party shall have to attend if re-work occurred due to leakage / jamming / passing of the valve, during the guarantee period, without extra cost.
16. Payment will be made per number of valve, if all activities mentioned above have been carried out, otherwise payment will be made at actual quantity of valves after satisfactory inspection carried out (pro-rata basis).
17. All required spares for the valves to be provided by the contractor including consumables like Body gasket, Gland packing, studs fasteners etc.

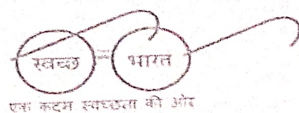
