Special Conditions:

1. All the bidders/tenderers/quotationers should ensure that they are GST compliant and their quoted tax structure /rates are as per GST Rules.
2. The Contractor should be registered under Goods &Service Tax (GST) and GST as applicable as per the extent order on the subject on the above work shall be paid by the contractor to concerned Department.
3. The work should not be sublet. The sub-contract is not accepted.

Eligibility Criteria:-

1. The contractor shall have independent code number for ESI & EPF & GST and necessary proof for the same be produced. Those who are having ESI & EPF Independent code number and GST only need apply. Others will not be considered.
2. The contractor should produce/submit document evidence in support of their having ESI & EPF Code and GST along with quotation. Otherwise the quotation will be rejected.

Terms & Conditions:-

Quotations should be in a sealed cover, duly Superscribed as the **“Patch - Up plastering work in D'M Plant and Raw water pump house inside the plant area at T.R.Pattinam, Karaikal.** The quotation to be sealed and brought to PPCL, T.R.Pattinam, Karaikal for placing in the Tender Box. The tender box is kept in PPCL, T.R.Pattinam, Karaikal, for dropping of quotation.

1. The rate to be quoted should be inclusive of material charges, labour charges, ESI & EPF contributions, and other inputs involved in the execution of work and **excluding GST 18%.**
2. The Quotation will be rejected if the quotation is not in sealed cover.
3. The decision of the Engineer in charge shall be final and binding on the successful quotationer.
4. The quotation shall remain valid for a period of 90days from the date of opening for acceptance.
5. If the date of opening of the quotation becomes holiday, then the same will be opened on the next working day.
6. The quantity mentioned in the schedule is tentative
7. The above payments are to be made by the contractor at his cost and it shall be the sole responsibility of the contractor to cover his workers under these provisions and no extra payment whatsoever would be made in this regard.
8. Payment will be released to the contractor within fifteen days from the date of submission of bills/invoice through A/c payee cheque only. Income tax and other taxes wherever applicable will be deducted from payments.
9. The total duration of the contract shall be for a period of two (2) Months .
- 10.If any of the personnel employed by the contractor is found to indulge in acts, subversive of discipline, the same will be brought to the knowledge of the contractor and he shall arrange for replacement of such personnel.
- 11.The contractor shall indemnify the company from the all liabilities arising out of deployment of personnel by the contractor under various statutory provisions and other issues related thereto
- 12.If the services of the contractor are found to be unsatisfactory during the stipulated contract period and for any other reasons, Engineer – in – charge reserves the right to pre-close the contract without assigning any reasons, whatsoever. However, the contract would be terminated by giving one – month notice.
- 13.The contractor shall furnish the list of persons to be deployed by him. He shall not engage persons below 18 years of age.
- 14.The rate to be quoted shall include all incidental expenses/ESI and EPF Act, Margin of profit etc.,
- 15.The company will not provide any transport /canteen facilities to the workers to be employed by the contractor and the contractor shall make necessary arrangements in this regard at his own cost.
- 16.All statutory laws relating to Factory to be complied with by the lowest tenderer.
17. The contractor is informed to inspect the site conditions before quoting his rates.
18. The contractor is liable for damages, defects during contract period.
19. Tools & Tackles to carry out the work shall be supplied by the contractor only.

20. Any damage that would be occurred to the property of PPCL during the time of operation of the work, the contractor has to rectify the same at his own cost.
21. The quotation will be rejected if the contractor failed to meet the terms and conditions of the quotation notice.
22. The undersigned reserves the right to accept /reject any or all the quotations without assigning any reasons thereof.
23. The contractor shall comply with all statutory provision with regard to the persons engaged by him, such as Employee's Provident Fund Act & ESI Act , Minimum Wages Act, contractor labour Act etc. During the period of contract / completion of the contract, all benefits due to the workers deployed by the contractor under various statutory provisions shall be paid by the contractor.
24. During the course of contract period, deduction of "CESS" to provide social security and various welfare benefits through the Puducherry Buildings and other construction workers Welfare Board under Section 18 of the Building and Other Construction Workers Cess collection (RECS) Act, 1996, shall be made at the rate of 1% (One Percent) of the gross amount of each bill or as per the advice of the Government of Puducherry.

Special Conditions:

1. All work is covered under Puducherry Goods and Services Act 2017 and hence the contractors are requested to quote the rates including the effect of GST. Additional/ separate claim for any recovery on GST will NOT be entertained on any account after the award of work. The payment is also liable for TDS as instructed by the Commercial Tax Department based on GST.
2. "The Contractor /Service provider shall mandatorily furnish the following documents to the Commissioner, Commercial Tax:
 - i. Copy of the work order.
 - ii. HSN Code of Goods and Service Accounts code of Services which shall be supplied during the execution of the Contract.
 - iii. GST Rate at which the GST would be paid to the commercial Tax Department against each of the items in (ii) above.
3. The information shall be submitted to the Commissioner, Commercial Tax , with a copy to the Procuring/Government Entity, within 15 calendar days of receipt of the Work Order."

Terms & conditions with respect to ESI & EPF and Payment.

1. This work is covered under ESI & EPF Act, and it is responsibility of the contractor to ensure compliance of ESI and EPF norms. Hence the contractors are requested to quote the rates including the effect of ESI & EPF. Additional/Separate claim for ESI & EPF will not be entertained on any account after the award of work.
2. The contractor should have independent code number for ESI & EPF and the contractor shall make pay make payment for ESI & EPF in own code number other than PPCL code. No permission shall be given for PPCL code.

PAYMENT: 80% Payment for the completed work will be made within 30 days for the running bills as well as final bill and the balance **20%** Payment will be made after submission of ESI&EPF etc. documents.

The **balance 20%** Payment will be made only after submission of the following.

Party should obtain all permits and licenses under the laws or regulations applicable and in connection with the work carried out and shall comply with and discharge all statutory obligations/liabilities under the various laws such as Factory Act/Workmen's Compensation Act/ Employee's State Insurance Act/ Employee's Provident Fund Act / Payment of Wages Act/Contract labour (Regulation &Abolition) Act/ Minimum Wages Act etc., or any modification thereof.
