- 1. Gas Turbine Generator cooler #5 blind plates to be removed inside/outside duct to be cleaned/ inspected and painting has to be carried out. If required, necessary repairing work has to be carried out.
- 2. Gasket preparation, fixing of Gaskets and inserting the new tube bundle in position #5 as per the instruction of Engineer- in Charge.
- 3. After fixing cooler bundle, its cooling water inlet and outlet pipelines/fittings are to be refixed as per the existing system.
- 4. During the execution of the above work, if modification required for proper fixing the new cooler, during connecting the pipelines, etc. necessary welding, cutting to be carried out.
- 5. After assembling work, tightness checking of water side/ air side.
- 6. Generator cooler#2, cooling water line inlet and outlet valves to be replaced by new.
- 7. After charging of cooling water, if any water leakages in the system, i.e to be attended.
- 8. The ACW pump #1 discharge valve and its NRV replacement work.
