- The Sulfuric acid should be supplied as single lot, after PPCL intimation of supply and should be directly supplied to the PPCL site, T.R.Pattinam, Karaikal - 609 606, on door delivery basis and shall be unloaded in our existing Storage tank.
- Payment will be made within 30 days from the date of receipt of your Invoice after receipt of materials at site in good condition. The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment.
- Applicable taxes and charges to be stated individually. Our GSTIN No.: 34AAACP6507E1ZS and PAN No.: AAACP6507E
- Any loss or damage during transit to site should be replaced by the supplier free of charge provided the same is reported within 15 days of the arrival of material at site.
- The delivery period and mode of dispatch should be clearly specified.
- Supplier shall unload the material at his own cost, after clearance of the quality section. If the material is rejected for quality reasons, then the supplier shall at his own cost, take back and replace the same. All weighing charges shall be borne by supplier.
- Sealed quotations should be super scribed as "QUOTATION/ENQUIRY NO. CP-292-D/PUR/2024-25 for the supply of Sulfuric acid due on 16.12.2024".
