- 6. EARNEST MONEY DEPOSIT: An Earnest Money Deposit of Rs.6,000/- (Rupees Six thousand only) should be paid by demand draft drawn in favour of the Executive Engineer (Mech), Puducherry Power Corporation Ltd T.R. The earnest money deposit will bear no interest and will be released after successful completion of the supply and acceptance. The EMD will be returned to unsuccessful bidder on receipt of a letter requesting for the same after placement of order to the successful bidder.
- 7. **PSU & Parties registered with NSIC/SSI/MSME are exempted for submitting EMD/SD**. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
- 8. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money" and "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. GENERAL CONDITIONS

- The AMC is for preventive as well as for breakdown maintenance of equipments and accessories fitted with air conditioner plant installed at Puducherry Power Corporation, Karaikal.
- 2. Presently, both the AC Plants are smoothly running and performance of AC Plants are satisfactory. The components/accessories of air conditioner plant are working condition with reputed/branded make.
- 3. Preventive maintenance service would be carried out by the Contractor regularly to keep the equipment running in a trouble free condition during the period of contract. All the faults will be attended at site of Corporation.
- 4. The Contractor must have an experience in maintenance & operation of Air-conditioning plant and must have executed similar work and should provide documentary evidence in this regard. Self attested copy of documentary proof as required above must be furnished along with their offer.

- 5. The AMC Contract will be awarded for a period of one year from the date of awarding the contract. The period of AMC can be extended for another one year based on mutual agreement/contract.
- 6. The interested bidder should inspect the AC plant submitting their bids. The plants can be inspected on any working day between 11:00 hours and 17:00 hours with the Engineer in charge or authorized representative of PPCL. The tenders' must thoroughly inspect the systems and furnish their quotes in **-as is where is** condition without stipulating any preconditions.
- 7. The maintenance charges quoted by the agency per item are on yearly basis inclusive of all taxes and levies applicable. No escalation of prices shall be permitted on any ground.
- 8. The AMC premium will be released quarterly at the end of each quarter on production of bill and service reports.
- 9. This is the sole responsibility of the contractor to submit the service reports of scheduled/breakdown service report at the time of submission of bill.
- 10. The required tools and plants for carrying out the work shall have to be arranged by the Contractor at his cost and no tools will be arranged by PPCL. The Contractor shall keep all required tools at site.
- 11. During this period the contractor will be liable for 01 overhauling of both the plant during the period of contract. The overhauling is supposed to be carried out at the start of the contract or at the middle of the contract.
- 12. The contractor should deploy adequate number of skilled/semi skilled labours. The Technicians are to be competent and have experience in handling Air-conditioning plants.
- 13. Arrangement of necessary tools, instruments and other necessary items for operations, maintenance and servicing work will be the sole responsibility of the contracting agency. Refrigerant gas pipe coil & fittings, brazing tolls consumables are contractor's scope.
- 14. The PPCL shall supply the consumable materials and spare parts. The contractor should intimate the essential and necessary spare parts during contract period well in advance so that it can be procured by PPCL for ready requirement.

- 15. Scrap generated out of replacement of dur4ing work is to be stored in PPCL scrap yard.
- 16. The contractor must ensure the comfortable conditions inside the Air-conditioned area while keeping the machine parameters normal.
- 17. The contractor will be liable to handover the plant in running condition with all the equipment serviceable at the end of contract or termination of contract.
- 18. As far as possible, the contractor will engage same manpower for the job defined in the work-scope so that there is continuity of work and the job quality does not suffer.
- 19. The period of contract will be one year from the date of award of work and may be extended for a further period of one year depending upon the satisfactory performance and on the same rates, terms and conditions. However, decision of the Engineer-in-charges shall be final in this care.
- 20. No additional payment will be made for transportation of equipment from the PPCL to parties work shop or delivery of the materials to the PPCL at any point of time.
- 21. The works of urgent nature should be attended immediately whether it is office hours or holidays for which no additional charges will be payable. If the part fails to maintain or to carry out the repairs of any defect to the satisfaction of the office, then the PPCL, in order to keep the A/C plant running will undertake the works of getting it done through outside agency and cost incurred thereby will be deducted from the contractor's bills.
- 22. All Compressors should be maintained in optimum condition. The compressors will be checked for proper functioning. The defective spares and consumables like oil will also be supplied by the Corporation as and when required.
- 23. Refrigerant gas will be provided by PPCL as and when necessary.
- 24. Every effort will be made by the Contractor in servicing condenser if they go beyond repair, they would be replaced by the PPCL. However, the labours cost for replacement will be borne by the contractor under maintenance contract.
- 25. Works related to replacement of AHU, sheet metal panels, base tray and thermal insulation – materials will be provided by PPCL, work to be carried out by the Contractor under AMC.

26. Works related to refrigerant gas piping like welding work, leak arresting with materials will be done by the contractor under AMC.

- 27. Replacement of valves in the cooling water, but effort should be made to repair/rectify by servicing. The valves required for replacement will be supplied by the ppcl and the work will be borne by the contractor under AMC.
- 28. Inspect Micro filters in AHU. Replace if necessary, the Micro filters will be supplied by the PPCL and the work will be done by the contractor under AMC.

SCOPE OF WORK:

I. PREVENTIVE MAINTENANCE

A. Monthly:

- 1. Routine inspection and maintenance works of all the 02 plants to be done in any one of working day.
- 2. All safety and indicating devices to be checked up.
- 3. Current & Voltage measurements for all the plants in full load.
- 4. Routine inspection and maintenance of control panel electrical items like Switches / Cables etc.
- 5. Cleaning of air filters and replacement whenever required.
- 6. Cleaning of air filters and replacement whenever required.
- 7. Inspection of belts and adjustment / replacements if required.
- 8. Checking of AHU fan motor, Impeller, impeller housing, shaft, bearing and replacement if required.
- 9. Recording various readings and calculating tonnage of plants, calculating the plant efficiency.
- 10. Check up for possible leakages in the refrigeration system.

- 12. Cleaning of suction filters once in the month.

B. Quarterly:

- 1. Cleaning of AHU cooling coils.
- 2. Lubrication of bearing of motors and other machinery.
- 3. Tightening of V-Belts.
- 4. Cleaning of oil/refrigerant Strainers.
- 5. Checking of safety control and solenoid switches/replacement if required.
- 6. Calibration of meters and gauges/replacement if required.
- 7. Cleaning of contract switches, checking of relays, timer etc/replacement if required.
- 8. Cleaning of AHU outlet like diffusers, grills etc,

C. <u>Annually:</u>

Overhauling of complete AC Plant and Accessories:-

Total plant overhauling shall be once a year as per instruction of Engineer-In charges. Prior permission shall have to be taken from the Engineer-in-charges for the job. (Required materials shall be supplied by the PPCL)

- 1. Condenser to be de-scaled on yearly basis.
- 2. Compressor to be accessories to be serviced.
- 3. Control panel along with gauge to be serviced.
- 4. A.H.U coil to be cleaning with suitable chemical.
- 5. Damper and duct with diffusers to be serviced.
- 6. Any other part of the AC plant, not covered by the above, to be serviced also.

II. BREAKDOWN MAINTENANCE:

1. The contractor should attend to the unscheduled service calls as and when required within 8 hours for locating the faults and rectify the same.

2. In case of any break down or any abnormal functioning of the equipment, the same has to be corrected within stipulated time as per instructing of the Engineer-in-Charges.
