6. PSU & Parties registered with NSIC/SSI/MSME are exempted for submitting EMD/SD. However copies of supporting Documents/Certificates should be kept in separate cover super scribing "Earnest Money Deposit Exemption".
7. The party shall be required to place the earnest money and the tender in separate sealed envelopes marked "Earnest Money and PQR" & "Tender" respectively. Both the envelopes shall then be placed in another sealed envelope and submitted to the tender inviting authority in the usual manner. The officer opening the tenders shall first open the envelope containing the earnest money and PQR. If the earnest money and PQR is found to be in order, only then the Officer shall proceed further with opening the tender. In case the earnest money is not deposited or is not in order, the tender will be rejected.
8. The delivery period and mode of despatch should be clearly specified.

TECHNICAL SCOPE AND SPECIFICATION

1. A maximum cooling water temperature of 40°C shall be considered for design of sample cooling system.
2. Capacity of cooler shall be adequate to cool the sample within 5°C of cooling water inlet temperature considering the combined flow of each analyser connected to sample cooler and one manual grab sample at flow rate 500 cc per minute assuming adequate flowing factor.
3. Cooler capacity calculations shall be submitted by bidder. GA drawing should be submitted along with offer for our approval.
4. Provision shall be made for adjusting the temp. of each sample individually at an optimum value.
5. Sample cooler shall be of submerged helical coil type of shell and tube design with removable shell. The sample tube shall be of seamless with no welds and other joint inside the cooling jacket. Unions shall be provided to facilitate removal of coils.
6. All sample tubing and fittings, other components shall be constructed of type 316 stainless steel.
7. Cooler design shall conform to requirement of ASTM D1192-64 (Equipment for sampling industrial water and steam).
8. IBR certificate is required wherever applicable.
