



# SCOPE OF WORK FOR PROVIDING SHEDS FOR BFP MOTOR

- 1. Removal of existing damaged shed and shifting to PPCL scrap yard.
- 2. Supply of required 2" inch GI pipe, 1.5 X 1.5 square tube, GI sheets, consumables.
- 3. Necessary fabrication of frame work for shed which includes necessary cutting, welding and fixing in position.
- 4. The contractor should deploy essential manpower and should complete the work in single sitting.
- 5. Necessary welding machine, cutting set, cutting machine, other tools & amp; tackles. Consumables, paints and safety equipments are under contractor's scope.
- 6. The sheds to be provided is to have wheel arrangements so that it can be moved during maintenance works.
- 7. Applying one coat of metal primer and two coat of smoke grey paint.
- 8. After completion the contactor should make the place neat and cleaning etc. as directed by the Engineer-in-charge.
- 9. The party may visit the site before submitting the offer.
