

#### SCOPE OF WORK FOR REWINDING OF RAW WATER PUMP MOTOR

- 1. The motor to be taken from site for rewinding & repairing.
- 2. Rewinding to be carried out with new copper coils in all three phases and with F class insulation.
- 3. New bearings SKF 6212 C3 to be replaced both DE and NDE side. The test and warranty certificates for the bearings are to be produced.
- 4. Any machining cost that may be required in motor servicing to be done in contractor scope
- 5. The terminal block / insulators of the motor if found damaged to be replaced.
- 6. Motor space heater if found not working to be replaced.
- 7. IF the cooling fan of the motor found in damaged condition it should be replaced under contractor's scope.
- 8. All spares and consumables required for rewinding and servicing of the motor is under contractor's scope.
- 9. Necessary routine tests, Insulation test, winding resistance, no load test on the motor to be carried out and report submitted.
- 10. The contractor should provided performance and service guarantee for the period of minimum six months.
- 11. Two coats of Painting (Smoke Grey Color) of the motor to be carried out.
- 12. The motor after completion of servicing to be delivered at site.
- 13. If any abnormal sound /overheating/abnormal current observed at no load and full load condition it has to be rectified by the contractor at their own cost for smooth operation.
- 14. In case of any faulty workmanship in the above scope of work, the party must rectify the same at their own cost.


