

SCOPE OF WORK FOR REPAIR/REPLACEMENT OF GAS TURBINE GENERATOR COOLER.No-4 GAS TURBINE GENERATOR COOLER

- 1. GT generator cooler No-4 (from bottom) is to be taken out from its position. (From the air Duct)
- 2. Old cooler which was removed from the duct is to be inspected for leak by hydraulic testing up to 6.5 kg/cm2.
- 3. If any leak is identified, it is to be plugged. Again cooler is to be hydraulically tested.
- 4. After testing, cooler bundle to be inserted in the generator Air duct system.
- 5. Gasket preparation, Fixing of gasket and boxing up of the cooler.
- 6. Tightness checking of waterside.
- 7. Re-fixing of all inlet and outlet valves and branch pipes.
- 8. After charging of cooling water if any water leakages in the system that is to be attended.

PPCL SCOPE:

- 1. Crane will be provided by PPCL.
- 2. Testing fixture arrangement will be provided by PPCL.
- 3. Consumables will be provided by PPCL (Rubber gasket, water gasket, paint brush, wire brush for cleaning etc.)

CONTRACTOR SCOPE

- 1. Mobilization of manpower by the contractor should start at least three days before shut down of the unit.
- 2. All tools and tackles (Chain block, slings Rope and rigging materials) are contractor's scope.
- 3. Scaffolding to be arranged by the contractor.
- 4. Work should be completed within 2 days (48 Hours) from the date of plant shutdown.
- 5. The party should visit the site before quoting the rate.
