**Contractor scope of work:**

**WORK FOR GBC - 2 DISTANCE PIECE REPAIR / REPLACEMENT WORK AT PPCL SITE**

1. The party should visit the site before quoting their offer. The rate should be quoted for on lump sum basis.
2. Welding and gas cutting inside the Gas Compressor house is not allowed. However welding and cutting will be allowed in maintenance area.
3. The contractor should follow all statutory safety rules inside the plant area during the execution of the work.
4. The contractor should provide Personal Protective Safety Equipments to their employees / workers during execution of the above work.
5. Welding machine, required length of welding cables, Power cables, Gas cutting set with oxygen, acetylene cylinders to be arranged by the contractor before starting the work.
6. All tools, tackles, manpower to be arranged by the contractor.
7. Supervisor, skilled technician, welder and technical helpers should report to the engineer in charges identified by the PPCL, well before commencement of the work. Minimum four persons to be deployed till the completion of work.
8. Skilled technician should have previous experience in any industry.
9. Before starting the dismantling, GBC - 2 should be cleaned externally by manual wire brush, scraping etc. The oil / grease around the GBC to be cleaned with soap solution and water.
10. Dismantling and assembling of connected pipeline, connecting rod, piston, packing's etc related to Distance piece replacement work as per the instruction of PPCL staff/Engineer to bearing housing.
11. Corroded cooling water inlet and out let pipe line at GBC - 2 areas as indentified by the Engineer Incharge with flange & fittings are to be replaced/patch welded according to site condition. (approximate 4 inch pipe of 6 meters with fittings)

12. Anti corrosive Metallic primer 1 coating and epoxy (painting 2 coating to be applied on outer surface of GBC equipments/pipe lines as per the instruction of PPCL Engineer. (approximate 50 square meter)
13. No load trial and load trial has to be carried out. If any correction required after trial operation, it also to carried out.
14. After completion of work all the scrap materials should be dumped to scrap yard as per the Engineer in-charge.
