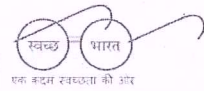

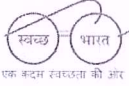
1. The rate quoted should be inclusive of providing manpower, transport charges, GST/ESI/EPF all taxes and other charges as admissible.
2. Applicable other charges, if any should be clearly mentioned. If not mentioned, it will be presumed that the rate quoted is inclusive of all other charges.
3. The rate has to be quoted in the prescribed tabular column format for all items each for work measurement. **The L1 rate shall be arrived based on the lowest rate quoted.**
4. The man power is to be supplied to PPCL site, T.R.Pattinam, Karaikal 609 606.
5. Exact date for commencement of GBC work will be intimated appropriately and the work has to be complied as per the directions of the Engineer-in-charge.
6. Necessary Gate pass should be obtained well before the commencement of work.
7. The Name List and I.T.I. Certificate of the skilled manpower are to be submitted well in advance before commencement of Works.
8. The number of manpower is estimated quantity. The actual number of manpower may increase or decrease based on the Plant site conditions during work progress.
9. In case of any faulty workmanship in the scope of work, the tenderer must rectify the same on free of Cost.
