#### **ANNEXURE-1**

#### SCOPE OF WORK:

- 1. The party should visit the site to access the condition of the valves to be serviced, before quoting the rate. Work to be carried out in their work shop.
- 2. Transport charges will be borne by the contractor from PPCL to their workshop and vice versa
- 3. Dismantling of all valves and Cleaning of internal and external parts completely by Sand blasting.
- 4. Inspection of the seating area, valve body, bonnet etc.
- Repair the plug and seat by welding, grinding and lapping to get blue contact between seat and plug. Appropriate welding electrode to used for plug and seat repair work
- 6. Lapping the Seat surface and blue matching for zero % passing.
- 7. Repairing by welding of damaged body bonnet and other parts by proper welding procedure.
- 8. Repair the back seating area of valve by welding, grinding and lapping to get blue contact.
- 9. Assembling of valves with new gasket, Grafoil Gland packing and replacement of worn-out fasteners.
- 10. Checking the valve spindle for smooth operation and for full opening / closing.
- 11. Checking the Gland packing & Bonnet joint for zero leakage. Checking the valve operation in full assembled condition.
- 12. Hydro testing of the valves to the Test pressure as per API 598. PPCL Engineer will witness the test before dispatch.
- 13. Painting of Valves by proper procedure.
