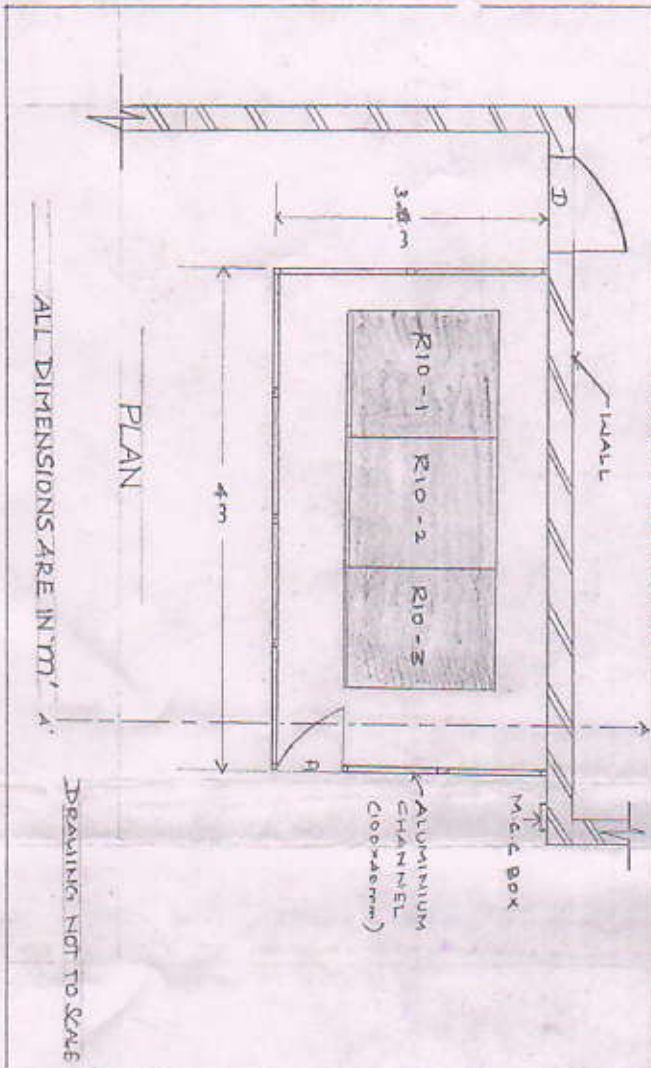
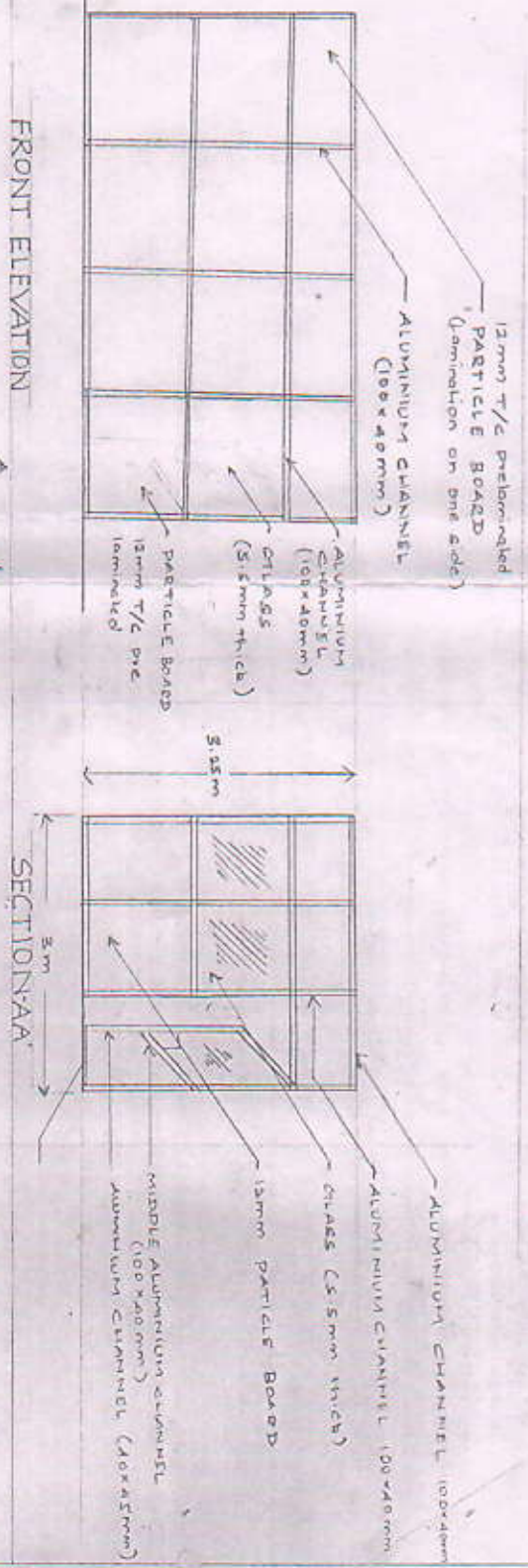
1. Supply of required Materials, consumables to complete the Installation of Aluminum Cabin for RIO3 panel at MCC inside the PPCL Premises.
2. Necessary fabrication of frame work for shed which includes necessary cutting, welding and fixing in position.
3. The contractor should deploy essential manpower and should complete the work in single sitting.
4. Necessary welding machine, cutting set, cutting machine, other tools & tackles. Consumables, paints and safety equipments are under contractor's scope.
5. The Cabin is to be provided with aluminum door, window, ventilator shutters and partitions etc with EPDM rubber, neoprene gasket etc. complete as per the architectural drawing with float glass panes of 5.50mm thickness.
6. After completion the contractor should make the place neat and cleaning etc. as directed by the Engineer-in-charge.

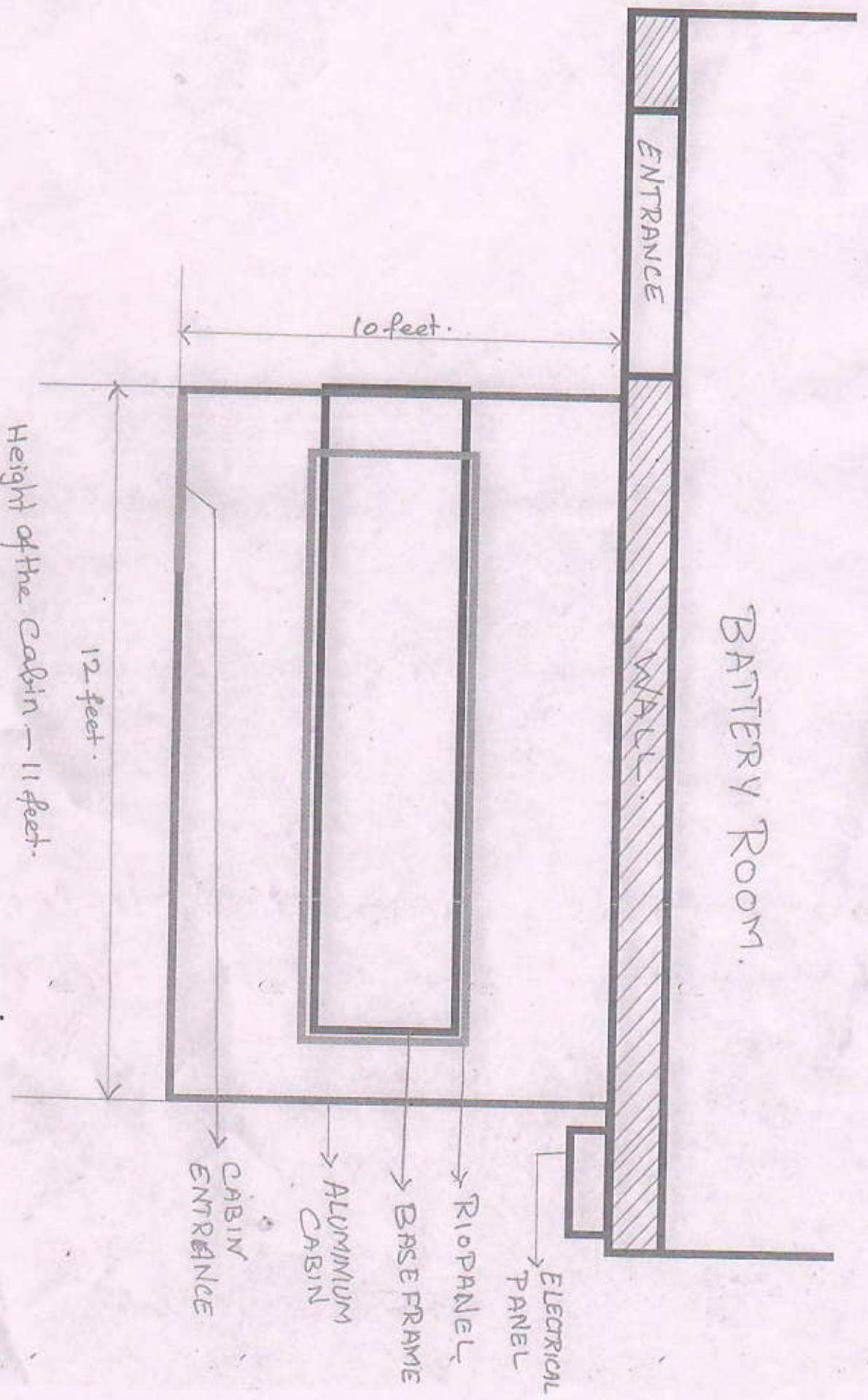
PLAN
