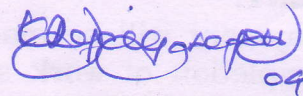

Scope of Works for Testing & Fault locating of UG cable from PPCL-Substation to 11KV feeder.

1. In the 11KV PPCL Feeder, the existing HT Aluminum armored XLPE cable of size 3Cx400Sq mm of length 70mtrs approximately should be tested by the contractor.
2. The Contractor should bring all the testing equipments such as Hi-pot kit, Megger, Cable fault locator, tools & tackles, Consumables and etc required for testing the UG cable problem at PPCL site.
3. The Contractor should have valid calibration certificate for the testing instruments used at site.
4. The contractor should mobilize sufficient skilled technicians to complete the job within the stipulated period.
5. Testing & Transportation charges and etc for the above said work are under contractor's scope.
6. Before submitting the offer the contractor may visit the PPCL Site for inspection of 11KV PPCL UG Cable.
7. After completion of testing work the agency should furnish the test report with recommendations,
