PRE-QUALIFICATION REQUIREMENTS:

THE BIDDER SHOULD HAVE EXPERIENCE IN PIPE LINE RELATED WORKS IN ANY POWER PLANT / INDUSTRIES. THE SUPPORTING DOCUMENTS SHOULD BE ENCLOSED WITH THE OFFER.

TERMS AND CONDITIONS:

- 1. The rate quoted should be inclusive of manpower, tools and tackles, etc. required for the works, all taxes, EPF & ESI charges and other charges as admissible. GST Compliance will be made as per the latest GOI orders.
- 2. EARNEST MONEY DEPOSIT: An Earnest Money deposit of Rs.4,800/- (Rupees Four Thousand and Eight Hundred only) should be paid by demand draft drawn in favour of the Executive Engineer (Mech), Puducherry Power Corporation Ltd T.R. Pattinam, Karaikal on any Nationalized/Scheduled bank payable at Karaikal. The same should be enclosed along with tender / quotation failing which tender will be summarily rejected. The earnest money deposit will bear no interest and will be released after successful completion of the works and acceptance. The EMD will be returned to unsuccessful bidders.
- 3. 100% Payment will be made within 30 days from the date of receipt of your invoice after completion of work satisfactorily and approval of Engineer-in-charge and after submission of EPF/ESI, etc. documents. Otherwise 80% payment will be made after completion of work satisfactorily and approval of Engineer-in-charge and the balance 20% payment will be made after submission of necessary EPF & ESI, etc. documents.
- 4. The bill in triplicate along with advance stamped receipt should be sent to the undersigned for effecting payment.
- 5. Rate should be quoted per work in the tabular column attached, for measurement purpose. The L1 position shall be arrived on total amount quoted basis for completing the entire scope of work furnished in the annexure.
- 6. The bidder shall make payments for ESI & EPF in separate code number other than PPCL code. No permission shall be given for PPCL code

- 8. Necessary Gate pass should be obtained well before the commencement of work.
- 9. All the Safety Rules as per the Factory certificate under Pondicherry shops and Establishment Rules 1964 as a Employer of the Establishment to be permitted to employ persons under their firm and also obtain Labour Act 1948, Puducherry Factory Rule and PPCL Safety instructions to be strictly followed inside the plant area.
- 10. In case of any faulty workmanship in the scope of work, the tenderer must rectify the same. Otherwise the estimated amount will be deducted in your work bill.
- 11. Our GSTIN No.: 34AAACP6507E1ZS registered with Commercial Taxes Department, Puducherry.

ANNEXURE - I

Contractor scope of work:

- 1. The party should visit the site before quoting the rate.
- 2. The Contractor should take care of their staff safety. Necessary PPE's should be arranged by the Contractor for their staff .
- 3. Pre-fabrication of pipe line, reducers etc as per existing layout and as per the instruction of engineer in charge should be done well in advance at our site during working hours / days. Date will be informed to the contractor to start pre fabrication work.
- 4. At least two days before the shutdown of the unit, the Contractor has to mobilize their manpower, tools and tackles for installation.
- 5. Erection of all above pipe lines in position and lifting of materials by using suitable hydra crane.
- 6. Necessary scaffolding materials and sufficient labour are to be arranged by the contractor so as to complete the entire work on stipulated period.
- 7. Welding machine, welding cable, cutting set and Gas cylinders to be arranged by the contractor. Wherever necessary, welding and gas cutting works at position is to be carried out without disturbing the existing system. Welding machine (2 Ph. / 3 Ph.)/ Generators / rectifiers only permitted for all welding works.
- 8. IBR welder with NDT testing (Radiography test) essential for GBC area gas discharge pipe line rerouting work (serial number-10).
- 9. Supply and application of IS approved brand epoxy (Green color) paints of two coats each (primer and finish) over the surface of replaced pipes & fittings by air or air less spray gun.
- 10. Painting materials and brush (Consumables) are contractor's scope.
- 11. Leak test to be carried out if any leakage is there that is to be attended.
- 12. The work should be completed within 05 days.
- 13. The rate should be quoted for each work separately.
- 14. After completion of work all the scrap materials should be dumped to scrap yard as per the Engineer in-charge.
