### Contractor scope of work:

- 1. The party should visit the site before quoting the rate.
- 2. The Contractor should take care of their staff safety. Necessary PPE's should be arranged by the Contractor for their staff.
- 3. Remove the vent fan ducts and supporting structures ,fittings etc,
- 4. Remove the exhaust plenum top cover from the gas turbine.
- 5. Inspect the top flange and clean the surface.
- 6. Remove the flange bolts and remove the plenum cover.
- 7. Check the distortion and if required corrections of the plenum top flange to be done.
- 8. If any abnormalities found in the top flange and inner flange that is to be corrected.
- 9. Preparation of Gasket (marking and cutting) and fixing over the plenum flange.
- 10. Positioning and fixing with bolts and nuts.
- 11. If bolt holes mismatch is there that is to be corrected and structure buckling to be corrected.
- 12. Replacing the insulation materials with new.
