Scope of work for doing Vibration Analysis:

### Only Level-2 (ISO 18436-4: 2014) Qualified competent personnel.

- a) The vibration analysis should be carried out by Level-2 (ISO 18436-4:2014) qualified competent personnel only.
- b) The concern will permit to do the Vibration analysis in General shift hours (i.e., 9.00 hrs to 17:00 hrs) except holidays.
- c) Necessary gate pass should be obtained for their staff well before the work to be started.
- d) The concern should submit the detailed individual equipment reports (hard copy & soft copy ) within a week after completing of their work in site.
- e) The concern should follow the safety rules as per the factory act 1948. The workers and staff should use PPE during execution of work.
- f) The concern has to do the vibration analysis on the equipments listed below, as per the Engineer in-charges.
- g) All required Tools & instruments needed for above job such as vibration analyzer etc, for carrying out vibration analysis dynamic/trim balancing shall be arranged by the contractor only.
- h) Contractor should quote their rates including TO & FRO travel charges, transportation of equipment, local conveyance and accommodation charges etc.
